

COMMERCIAL LICENSE CONTRACT

This Commercial License Contract ("Agreement") is made between:

Licensor: Anton Tomin, independent music composer and rights holder.

Licensee: [Client / Company Name], with principal address at [Address].

1. Grant of Rights

Licensor grants Licensee a non-exclusive or exclusive, worldwide, non-transferable license to use the selected musical work(s) (the "Track") in accordance with the chosen license type. All copyrights and ownership remain with Licensor unless otherwise stated in a signed Exclusive Agreement.

2. License Types

Standard: Online videos, podcasts, social media, and personal projects (non-broadcast).

Extended: Online advertising campaigns, apps, games, corporate videos, paid promotion up to 20 million impressions.

Broadcast: Television, radio, cinema, and large-scale media placements.

Exclusive / Buyout: Full exclusive rights. The track is removed from sale and assigned solely to Licensee under negotiated terms.

3. Restrictions

Licensee may not resell, redistribute, or upload the Track as stand-alone audio, claim authorship, submit to DSPs (Spotify, Apple Music, etc.), share stems with third parties, or use the Track to train AI models.

4. Modifications

Licensee may edit for length, timing, fade, and EQ; mix with dialogue or sound effects; and create cut-downs. No new derivative works may be created beyond these technical edits.

5. Term & Territory

Unless otherwise agreed in writing, this license is perpetual and valid worldwide for the declared project.

6. Payment & Taxes

Licensee shall pay the license fee as stated on the invoice. All payments are final and non-refundable after delivery. Taxes and processing fees are borne by the Licensee.

7. Attribution

Credit is not mandatory but appreciated: "Music by Anton Tomin" or a link to the official website.

8. Content ID and Claims

Tracks may be registered in digital content ID systems. If Licensee receives a claim (e.g., on YouTube), they may contact Licensor with proof of purchase to whitelist within 48 hours.

9. Warranties & Liability

Licensor warrants ownership of rights to the Track. Total liability of Licensor shall not exceed the license fee paid. The Track is provided “as is” without further warranty.

10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of [Jurisdiction]. Any disputes shall be resolved in [Venue/Court].

11. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior communications. Modifications must be in writing and signed by both parties.
